# THE PROTOCOL ON PARTICIPATING OF THE STUDENTS IN THE LEGAL CLINICAL PRACTICES FOR THE LAW NUMBERED 6284 AMONG THE MINISTRY OF JUSTICE, THE MINISTRY OF FAMILY AND SOCIAL POLICIES, THE PRESIDENCY OF THE ANKARA BAR ASSOCIATION, THE RECTORSHIP OF THE ANKARA UNIVERSITY

#### **Parties**

**Article 1:** The parties of this protocol are The Ministry of Justice, The Ministry of Family and Social Policies, The Presidency of Ankara Bar Association and The Rectorship of Ankara University.

#### Aim:

**Article 2:** The aim of this protocol,

- 2.1) To inform the parties and those concerned by means of the legal clinical practices by the students of The Faculty of Law in Ankara University based on the principles and procedures within the scope of The Law numbered 6284 with the purpose of the protection of the women, children, family members and victims of stalking that expose to violence or are at the risk of exposing to violence and the prevention of violence in Ankara and Ankara West Courthouses (family courts and investigation bureau for the domestic violence), Ankara Women's Closed Prison and The Violence Prevention and Monitoring Centers (ŞÖNİM) affiliated with Ankara Provincial Directorate, The Ministry of Family and Social Policies and thus, to improve the Practices of The Law To Protect Family And Prevent Violence Against Women and to transfer directly the information activities about the Law to the claimants.
- 2.2) In order to achieve the goal, the informative brochures concerning the practices of The Law to Protect Family and Prevent Violence against Women numbered 6284 will be prepared and a website concerning the Law to Protect Family and Prevent Violence against Women will be created.

#### **Basis**

Article 3: They are The Articles 10 and 41 of the Constitution, The Law on Acceptance and Amending the Decree Law Concerning the Establishment and Functions of the Ministry of Justice numbered 2992, the Decree Law Concerning the Establishment and Functions of the Ministry of Family and Social Policies numbered 633, The Law on Higher Education numbered 2547, The Law To Protect Family And Prevent Violence Against Women.

## **Subject**

**Article 4:** It is to inform the victims of violence and those concerned by using the informative brochures created by The Ministry of Justice as the domestic violence justice unit by students in Ankara University about the basis and procedures of the measures for the protection of the women, children, family members and victims of stalking that are subjected to violence and at the risk of violence within the scope of The Law To Protect Family And Prevent Violence

Against Women numbered 6284 and prevention of violence for these persons, to enable the students to do the legal practical studies concerning this subject by means of an effective work, to form an informative website and to prepare brochures.

### Scope:

# **Article 5: The scope of this protocol,**

- a) To ensure the persons, who want to have information, to be informed by means of the brochures formed by The Ministry of Justice and the legal clinical practices by the students of The Faculty of Law in Ankara University in The Ministry of Justice, Ankara and Ankara West Courthouses, Departments to be provided by The Chief Public Prosecutor's Office and The Ministry of Justice Ankara Women's Closed Prison
- b) To enable the students of The Faculty of Law in Ankara University to be informed about the victims of violence in The Violence Prevention and Monitoring Centers (ŞÖNİM) affiliated with Ankara Provincial Directorate, The Ministry of Family and Social Policies with The Law to Protect Family and Prevent Violence against Women numbered 6284.
- c) To prepare the informative brochures concerning the practices of The Law to Protect Family and Prevent Violence against Women numbered 6284 by the Ministry of Justice,
- d) To be created an informative website concerning the practices of The Law to Protect Family and Prevent Violence against Women numbered 6284 by the Ministry of Justice.

# The Principles of the Protocol

**Article 6:** To give the necessary permission to the student to participate in the clarified activities in the courthouses and ŞÖNİMs and Ankara Women's Closed Prison and provide a tangible place in the courthouses and prison, the Violence Prevention and Monitoring Centers (ŞÖNİM) affiliated with Ankara Provincial Directorate and to ensure the students to take part in the activities regarding the legal information within the scope.

### **Responsible Units**

# Article 7: The institutions and units that are responsible for conducting the protocol are as follows:

- a) The Ministry of Justice, Directorate General For Strategy Development
- b) The Ministry of Family and Social Policies General Directorate on the Status of Women
- c) Ankara University, Deanship of The Faculty of Law
- d) The Presidency of Ankara Bar Association

### The Duties of the Parties

#### Article 8:

# 8.1 The Duties of the Ministry of Justice

The Duties of The Ministry of Justice are as follows:

- a) To give necessary permissions regarding the studies of the students in domestic violence justice unit and prison law clinic, Ankara University, The Faculty of Law,
- b) To provide an appropriate tangible place for the students in Ankara and Ankara West Court Houses with the aim of performing the legal clinical practices,
- c) To meet the expenses regarding the design, press and distribution of the brochures within the scope of the protocol and the website,
- d) To provide the transportation of the students in domestic violence justice unit and prison law clinic, Ankara University, The Faculty of Law to the units where the legal clinics will be done.
- e) To form the informative brochure and website regarding the implementation of the Law to Protect Family And Prevent Violence Against Women

# 8.2. The Duties of The Ministry of Family and Social Policies

The Duties of The Ministry of Family and Social Policies are as follows;

- a) To give the necessary permissions in order that the students dealing with the domestic violence legal clinic in Ankara University, The Faculty of Law provide the legal support for the victims of violence in Ankara ŞÖNİM on condition that the general functioning isn't prevented and the principles of confidentiality are obeyed within the scope of the applied training,
- b) To provide a place for the students dealing with the domestic violence legal clinic in Ankara University, The Faculty of Law in order to give the legal support to the victims of the violence,
- c) In case of detecting that the students act in a way to disrupt the general functioning of Ankara ŞÖNİM and contrary to the principle of the confidentiality regarding the information about the victim of violence, the Faculty of Law in Ankara University is informed of the situation with the purpose of removing the available permissions.

# 8.3. The Duties of The Presidency of Ankara University

The Duties of The Presidency of Ankara University are as follows;

- a) To determine the students to participate in the studies and notify the identity information of the students to The Ministry of Justice and The Ministry of The Family and Social Policy,
- b) To determine the coordination of the studies to be done and set standards by enabling the students to be in the stands on a regular basis.

#### 8.4. The Duties of the Presidency of Ankara Bar Association

The Duties of The Presidency of Ankara Bar Association are as follows;

a) To be given lessons regarding the legal practice by the lawyers of Ankara Bar Association in The Faculty of Law, Ankara University if required,

- b) To collaborate on the provision of the legal support for the victims of violence that apply to the domestic violence justice unit in The Faculty of Law, Ankara University within the scope of The Law numbered 6284,
- c) To ensure to the students in The Faculty of Law, Ankara University that will be assigned in ŞÖNİM to lead the relevant persons by giving information on telephone about the legal information needed concerning the victims of violence,
- d) To provide the legal support for the victims directed by the students in The Faculty of Law, Ankara University that will be assigned in ŞÖNİMs and to prepare the files together with the students,
- 8.3.5. To provide the legal support for the students of The Faculty of Law, Ankara University in the clinical legal studies to be done in Ankara Women's Closed Prison if required,
- 8.3.6. To provide the students of The Faculty of Law, Ankara University with an internship opportunity in Gelincik Center of Ankara University and to ensure the similar studies for the education of the students to be carried by Gelincik Center

#### **Violation of the Protocol**

**Article 9:** In the event that the parties shall not fulfill the duties and responsibilities assumed by this protocol and the services aren't functioned, the reconciliation principles are fulfilled by the negotiations to be done on the condition that the other party is informed of the situation
